BIOGRAPHY

Douglas A. Luke, PhD, is the Irving Louis Horowitz Professor in Social Policy at the Brown School at Washington University in St. Louis. He is the director of the Center for Public Health Systems Science (CPHSS), which has been active and funded for over the past 20 years. His research focuses on evaluation and implementation of evidence-based public health policies. He is also a leading methodologist with expertise in systems science, network analysis, agent-based modeling, and multilevel and longitudinal modeling. Based on a 2019 PLoS Biology bibliometric analysis, he has ranked in the top 1% of scientists in the world based on the number of highly cited papers. He received his PhD in community and clinical psychology from the University of Illinois, Urbana-Champaign, in 1990.
